#### Question:

#### Leave outstanding

1. What is the total annual and long service leave outstanding amounts (both \$ and hours) as at 31 December 2022 and what positions have leave outstanding in excess of the annual leave entitlement and/or long service leave beyond the 7-year accrual?

#### Answer:

Annual Leave 7,012hours \$323,146 Long Service 11,060hours \$517,233

There are 11 Employees that have greater than 20 days at 03/01/23

There are 12 Employees with greater than 7 years' service LSL (>345.8hours) at 03/01/23

2. What are the requirements pursuant to any of the Employment agreements in regard to taking of this leave?

#### Answer:

This is the excerpt out of both Enterprise Agreements

Leave balances are to be maintained at no greater than 20 days (152 hours for full time employees). Excess accruals are to be reduced within six (6) months of the accrual limit being reached at a mutually agreed time and during non-seasonal periods.

If leave is not taken to reduce the leave balance to 20 days within six (6) months of the accrual limit being reached, the Director of Works & Infrastructure will, in consultation with the employee, set the dates when the leave is to be taken.

Variations to the above arrangement will be considered only in special circumstances upon application.

#### Clare Caravan Lease

1. What written commitments for delivery of the water park at the park have been received by Council and when was that written information received?

## Answer:

February 13, 2023 the Chief Investment Officer (CIO) for Discovery emailed the CEO saying: "Plan is to commence build this year, targeting Christmas 2023. Our board will be signing off on the capex program at the end of March so I can confirm definite timelines after that. But Christmas 23 remains the target (which I think is consistent with all the messaging / media responses we've given)." 5 May 2023 the CIO confirmed that the Discovery Board had approved the above commitment.

2. When was the annual maintenance inspection of the park undertaken and when will such report be presented to the elected Council?

#### Answer:

The Inspection was undertaken on 7th March 2023. Everything was found to be in order however it was noted that the fire extinguishers had not been in over 12 months, regulations state inspections are required every 6 months. The test and tagging of electrical equipment was out of date, or had no tags on at all. The inspection and maintenance book in the Fire Tank Pump House has been kept up to date. Discovery were notified of these matters and asked to address it. This was reported verbally to the Wednesday 15th March Council meeting. Council made no resolution regarding the inspections of the Clare Caravan Park, to report to council on this matter or to provide the inspection report.
