Note: •

- All fees associated with the purchase of an Interment Right (IR) are to be paid before the IR will be granted •
- Council do not “reserve” sites for future use without payment
- The majority of graves are able to accommodate up to 2 burials, however, this is not possible in all locations
- Each niche wall site can only accommodate one container of ashes
- All sites have a term of either 99 years or perpetuity from date of purchase. The 99 year interment is not from the date of first interment, this can be extended or converted to a perpetual interment right.
- Requests for specific sites, will be considered, however, the final decision on location will be made by Council
- All fees payable are listed on the current Fees and Charges Register
