APPLICATION TO BE CONSIDERED AS A SINGLE FARM ENTERPRISE

Section 158(2)(bb), Local Government Act 1999

Single farm enterprises (SFE) means farm land (being land that is used wholly or mainly for the business of primary production) that is farmed as a single enterprise, and is occupied by the same person or persons. The land which constitutes the single farm enterprise can, but need not, be adjoining parcels of land.

It is possible for one of the parcels of land that comprises a SFE to contain a dwelling. In this case, in order for the land on which the dwelling is situated to be included in the SFE, the following criteria must be satisfied:

- The dwelling must be the principal place of residence for once of the occupiers of the SFE land; and
- The land containing the dwelling must adjoin at least one of the other pieces of farm land used for the single farm enterprise.

If different persons occupy any of the allotments subject of this application then the allotment will not be included with the balance of land that comprises a SFE (if any).

A SFE only arises in respect to the land within the area of a single Council.

If you consider multiple parcels of land in the Council's area constitute a SFE, you may apply to the Council for the land to be treated as an SFE for rating purposes under the Local Government Act 1999 by completing this form. If there is insufficient room in the tables provided, you may replicate the format on an additional piece of paper to be submitted with this application.
